

Dear Friends,

What a wonderful summer we had weather-wise but now fall is in the air. Homes has been hive-free for over 6 weeks (knock wood) so I just signed up to do the Lord Creek Hunter Pace for the first time in 2 years. I am so looking forward to it! It is so awesome to finally be able to ride my horse!

### Some general news:

Unfortunately Trish Panico has resigned as president of the Bridle Path Conservancy— Trish did terrific work bringing the BPC back from near stagnation, getting the 501c3 status reinstated, and working with the state on getting 100 yards of stone for repairing trail erosion in Weber Woods. We will sorely miss her but she has a lot going on, including building a new house, and she was concerned that she would not be able to give it enough attention. We begged and pleaded but...all good things must end. (Wait? Does that mean I am not really LCRVHC president for life? Kristin, did you lie to me?) We also have two inactive board members so we are actively seeking 3 candidates to serve. We welcome any trail users, they don't have to be horse people, in fact, we'd love some diversity--hikers and mountain bikers are encouraged. It's not a huge time commitment but it does require enthusiasm and rudimentary computer skills. If you are interested or have an idea of someone who might be, please let any board member of either organization know.

The July MO ride was cancelled due to lack of RSVPs. If you have ideas of where we should ride or feedback on MO Rides, please let us know. If you plan to attend a ride please try and let Lynda Perry know at least a few days ahead. It's very hard to plan when she doesn't hear from anybody until the night before the ride.

The summer picnic at Sue Davenport's was a good time, as always. The potluck dishes were yummy and of good assortment. No rain--we grilled without umbrellas! The weather was spectacular--cool and dry and comfortable enough to enjoy Sue's extensive patios and gardens. The silent auction raised over \$450 for the BPC. Thank you to Sue for hosting, Lynda Perry for shopping, Kristin Elliott Leas for organizing the silent auction, and all who brought and bought or participated in any form.

On July 27 Kristin and Chuck Sharples brought their tractors and I brought my rake and we spread 50 yards of stone on the white trail in Weber Woods, filling in one of the worst eroded sections. We will cover it with smaller stone later.





There were 3 rides in August: The MO ride was at Pachaug. From Lynda: There were seven riders on the Pachaug ride. The forest is beautiful with lots of dirt roads and many trails to explore. We parked at the Frog Hollow Horse Camp, which has solar outhouses as well as running water.

Then on August 23 the BPC held a barbecue ride and hike to celebrate the 10 year anniversary of the founding of the BPC and one of our biggest accomplishments to date: The Quinimay Trail. About 15 horseback riders, several hikers, and one mountain biker enjoyed the trails (except for the yellow jackets who were NOT invited!) followed by a chicken barbecue lunch catered by Hog Wild Smokin' Cue. Thank you to hosts Dave Beaudette and Julie Berman (Julie is the penultimate hostess, I have tablecloth envy!), organizers Chuck Sharples, Marlisa Simonson, Trish Panico, Nancy Palermo-Lee (who jumped in to pick up and serve the food when we failed to meet the caterer's minimum of 50 guests) and all the board members who helped make this event a reality. The August 28 General meeting was held at Guilford Riding School. Jill Walker-Robinson gave an informal presentation on getting started in Eventing. Another lovely evening allowed us to sit outside enjoying cider and cookies and watch some of Jill's students show us the attire and equipment, and demonstrate each of the three phases, while Jill talked about the history and requirements of the sport. One of my favorite programs this year. Maybe next year Homes and I will try it!

On September 6 a BPC work party including Kristin, Chuck, Dave Beaudette, Rebecca Russell and I spread the rest of the stone on the white trail in Weber Woods. I wish I was better about documenting this work and kept clear before and after shots from the same location. We made this trail from a rocky, almost stream-bed trench into a perfect canter track.









On September 7 five LCRVHC members and their equines (Alyce Mallek with Doolin, Howard Tunic with Emma, Lynda Perry with Sparkle, Ben Wilke with Lynda's horse Tanner, and me with Homes) provided an equine program for a Scout Leadership Training weekend at Deer Lake Scout Reservation. We broke into small groups. Homes loved interacting with these adults who had mostly never even touched a horse. He allowed them to groom and lead him and help tack him up. Even gave some huge men short pony rides. It was fun hearing him referred to as in "I got to ride the big, black one!" I never think of him as big! He was extremely social and his manners were perfect. I was so proud of him.

# FALL FESTIVAL HUNTER PACE

Sunday, October 26, 2014



TIME & PLACE: NOTE: All trailers park in one location. No road crossings!

98 Stevenstown Rd., Deep River, CT 06417. Ride starts at 9:00 am

Check in starts 8:30 am. Must be checked in and on trail before 10:30 am to be included in placings.

COURSE: Trails through Weber Woods section of Cockaponset State Forest. ~9 miles.

Terrain is varied - open fields, flat stretches through the woods and a few hills. Jump course is optional.

TEAMS: 2 (max. 3) riders per team. If you are alone we will try to match you up with another rider.

DIVISIONS: Hunters (timed, competitive riders) and Hackers (timed, leisurely riders).

All riding disciplines welcome. Please indicate on the entry form which division you are entering.

The winning team in each division will be the team that completes the course closest to the perfect "fox-hunting" time as predetermined by officials. Places first through sixth get ribbons. A prize will be given for the best costume.

SAFETY: Safety helmets and footwear with heels are required! Chin strap required. Horses must be sound, and all equipment must be in good repair. A safety check will be made prior to the ride.

If tack and mount are considered unsafe, the entry fee will be refunded (less \$12).

DIRECTIONS: From I-95 Take exit 64, Rt. 145/Horsehill Rd. exit. Go north onto 145. Go 4.0 miles and turn LEFT (other side from past years) into driveway. Look for signs and drive to parking areas.

From Rt. 80 Head South onto Rt. 145/ Stevenstown Rd. Go 0.4 miles and turn RIGHT (other side from past years) into driveway. Look for signs and drive to parking area.

ENTRY INFO: Deadline for entry is Oct. 18, 2014. Entry fee is \$45 (\$40.00 for LCRVHC members).

Entries will be accepted from Oct. 19 - 25 if space is available at \$55 (\$50.00 for LCRVHC members).

Checks (made out to LCRVHC) must accompany the entry form. \$12.00 not refundable. We have a commitment to the caterers in advance of the event. Rain date will only be used if severe storms are predicted a few days in advance.

# RECKLESS


A TRUE STORY OF WAR, LOVE AND ONE EXTRAORDINARY HORSE

When the U.S. Marine Fifth Regiment's Recoilless Rifle Platoon acquired a small Korean pony to haul ammunition up the steep hills to the front lines, what they got was a real-life hero, Reckless, the courageous and indomitable warhorse who stood with her buddies for two years during the Korean War, saving many lives, raising spirits, and winning the love and respect of all who knew her.

She came on base in October, 1952, disrupting a softball game and capturing the attention of everyone around. Immediately named for the "reckless" rifles she would supply, she began life with the Marines as Private First Class Reckless. In short order she was an integral member of the platoon, learning quickly to run into her bunker when incoming fire hit the camp, navigate the trails and hills on her own, and calmly accept the roar of the recoilless rifles at close range.

In skirmishes and firefights, and ultimately in the savage Battle for Outpost Vegas, Reckless showed her bravery and resilience. In that last bloody fight, surpassing all expectations, she hauled ammunition for three



days and nights wherever it was needed. For wounds sustained, she was awarded two Purple Hearts. Ever the character, she also shared her buddies C-rations and mess hall chow, beers and an occasional whiskey, and on cold nights, their warm tents. She was promoted to sergeant by the Commander of the Marine First Division. Then, in late 1954, the men got their wish, and Sergeant Reckless sailed for San Francisco, a hero's welcome, and another new life.

Now, for the first time, read her whole story, made possible by the contributions of more than 60 Marines who shared their memories of Reckless in Korea and thereafter. By turns heartwarming, awe-inspiring, and downright funny, "They Called Her Reckless" tells of an incredible human-horse connection, and the power it unleashed.

From the moment she heard about Reckless, Janet Barrett knew she would write this book. Her experiences as a horsewoman gave her a particular appreciation of the tight bond that developed between Reckless and her fellow Marines, from which the story springs. The author's first book was On The Fence: A Parent's Handbook of Horseback Riding; as well, she has written for magazines, newspapers, and the public relations field.
